

LSA Colorado/Nebraska laboratories provide full clinical testing services in Hematology, Chemistry, Microbiology, Blood Bank, Toxicology and Pathology. The NoCO Laboratories are open 24 hours a day, 7 days a week, serving routine and emergency needs of the hospital, physician's offices, clinics, and the community and performs most tests in-house. The remaining tests, consisting primarily of infrequently ordered tests, are sent to accredited reference laboratories, such as Sonora Quest Laboratories and Quest Nichols Institute.
